BIMWE MU BIBAZO BIGARAGARA MU MASOKO YA LETA

- Kwibanda cyane ku ngingo z'amategeko kurusha ibyo ayo mategeko yagombye gukemura: kugira ubwoba bw'amategeko ku buryo n'ibyo amategeko yemerera PE gukora usanga abayashyira mu bikorwa babihindura icyaha
- Gutinya gufata icyemezo (kwa bamwe n'abamwe) kirengera inyungu za Leta: *Niko amategeko abiteganyaga: urugero: gutanga isoko ku gaciro kanini cyane ngo ni uko rwiyemezamirimo ariwe waciye make kandi akaba yujuje ibisabwa*

Bimwe mu bibazo bigakigaragara mu masoko ya Leta

- Kudategura isoko neza (technical specifications / terms of reference) ngo ugaragaze neza ibyo PE ishaka kugura cyangwa services yifuza guhabwa. “PE ibona icyo yasabye rwiyemezamirimo aho kubona icyo yifuza”
- Kudakora “post-qualification” y’ugihe guhabwa isoko
- Kudategura amasezerano neza mbere yo kuyasinya, rimwe na rimwe ugasanga amasezerano arimo urujijo cyangwa zimwe mu ngingo zivuguruzanya cga hari iziburamo

Bimwe mu bibazo bigaragara mu masoko ya Leta

- Kudakurikirana neza ishyirwa mu bikorwa ry'amasezerano (contract management is the one of the most challenging and wanting area) aho usanga nta team yashyizweho (officially) ishinzwe contract management no kudakora inama kenshi.
- Gutinda kwishyura inyemezabuguzi za ba rwiyemezamirimo
- Kutabika neza inyandiko zose zirebana n'amasoko ya Leta;
- Kudatangeriza rubanda ibyavuye mu ipiganwa ku rubuga rwa PE no kuri notice board

Bimwe mu bibazo bigaragara mu masoko ya Leta

- Kudatanga cyangwa gutanga itameze neza raporo y'ishyirwa mu bikorwa ry'igenamigambi ry'amasoko atangwa na buri rwego mu ngengo y'imari
- Kudakora neza kwa bamwe bavugako akazi k'abatanga amasoko ari kenshi kandi gafite "risk" nyinshi

Bimwe mu bibazo bigaragara mu masoko ya Leta

- “qualification and evaluations criteria” ziteguye nabi zituma rimwe na rimwe ubujurire bwiyoungera
- Gukenera ibyiza ariko PEs ifite amafaranga make
- Uburyo amasezerano aseswa

IBIBAZO BIKUNZE KUBAZWA CYANE

- Ese urwego rwa Leta rwemerewe guheza rwiyemezamirimo wakoranye nabi narwo mu isoko igihe atarahezwa mu masoko ya Leta na RPPA?
- Ese rwiyemezamirimo wapiganiye isoko aramutse yasabye amafaranga make cyangwa menshi ugereranije n'abandi cyangwa n'agaciro kabazwe (estimated cost) yakwimwa isoko? Ese muri icyo gihe “negotiation kugiciro iremewe”?

IBIBAZO BIKUNZE KUBAZWA CYANE

- “addition contract (even more than 20%)” ku masoko ya “supervision” y’imirimo iyo ayo masoko y’imirimo yatinze kurangiza ugereranije n’igihe cyateganijwe
- Isubirwamo ry’ibiciro (unit prices revision) ku masoko arengenje amezi 9 ihurira he n’imirimo y’inyongera (additional contract)?
- Iyo habaye kwibeshya muri “quantity ya item runaka” cyangwa yaribagiranye muri DAO bikagaragara mugihe cya “bids evaluation” PE yakwifata ite?ese PE yagabanya cyangwa ikongera “quantity” y’iyo “item” mbere yo gusinya amasezerano?

IBIBAZO BIKUNZE KUBAZWA CYANE

- Ikibazo cya “bid security” na “performance guarantee zitanzwe na banki cyangwa sosiyete z’ubwishingizi
- “Bids security” na ‘performance guarantee” ku masoko ya “physical/none- consulting services”
- Bid security, performance & advance payment guarantees validities
- Ikibazo cya “exchange rate”: PE ifata iy’iyihe tariki kurubuga rwa Interineti ya BNR? Ko uru rubuga rugaragaza “selling, buying and average rate” ni iyihe ifatwa na PE mugihe cyo kugereranya ibiciro? Rep. ITB 15.1

IBIBAZO BIKUNZE KUBAZWA CYANE

- Gutanga amasoko atarateganijwe n'inshuro igenamigambi ku masoko azatangwa mu mwaka w'ingego y'imari ivugururwa
- Iyo habaye conje itunguranye kuri uwo munsi PE yari gufungura inyandiko z'ipiganwa, gusurisha ahazakorera imirimo n'ibindi, bigenda gute?
- 5% (mbere yari 10%) ibihano by'ubukererwe bitagomba kurenga no gusesa amasezerano

IBIBAZO BIKUNZE KUBAZWA CYANE

- Amasoko atangazwa akabura ba rwiyemezamirimo bayapiganira cyangwa bayatsindira (causes: inappropriate method, problem in technical specification, etc.)
- Ese iyo umwe mu bapiganwe asabye guhabwa « Bids Evaluation report”, urwego rwa Leta rwemerewe kuyitanga?
- Uko batanga isoko rya “Individual consultance”

IBIBAZO BIKUNZE KUBAZWA CYANE

- “Evaluation of alternative bids” ikorwa ite?
- Kongera gutanga isoko iyo uwarikoraga rimunaniye (kongera kuritangaza cyangwa kuriha uwri wabaye uwakabiri mu biciro?). Ku isoko ry’imirimo, isoko rya “supervision of works” rirakomeza cyangwa rirahagara?
